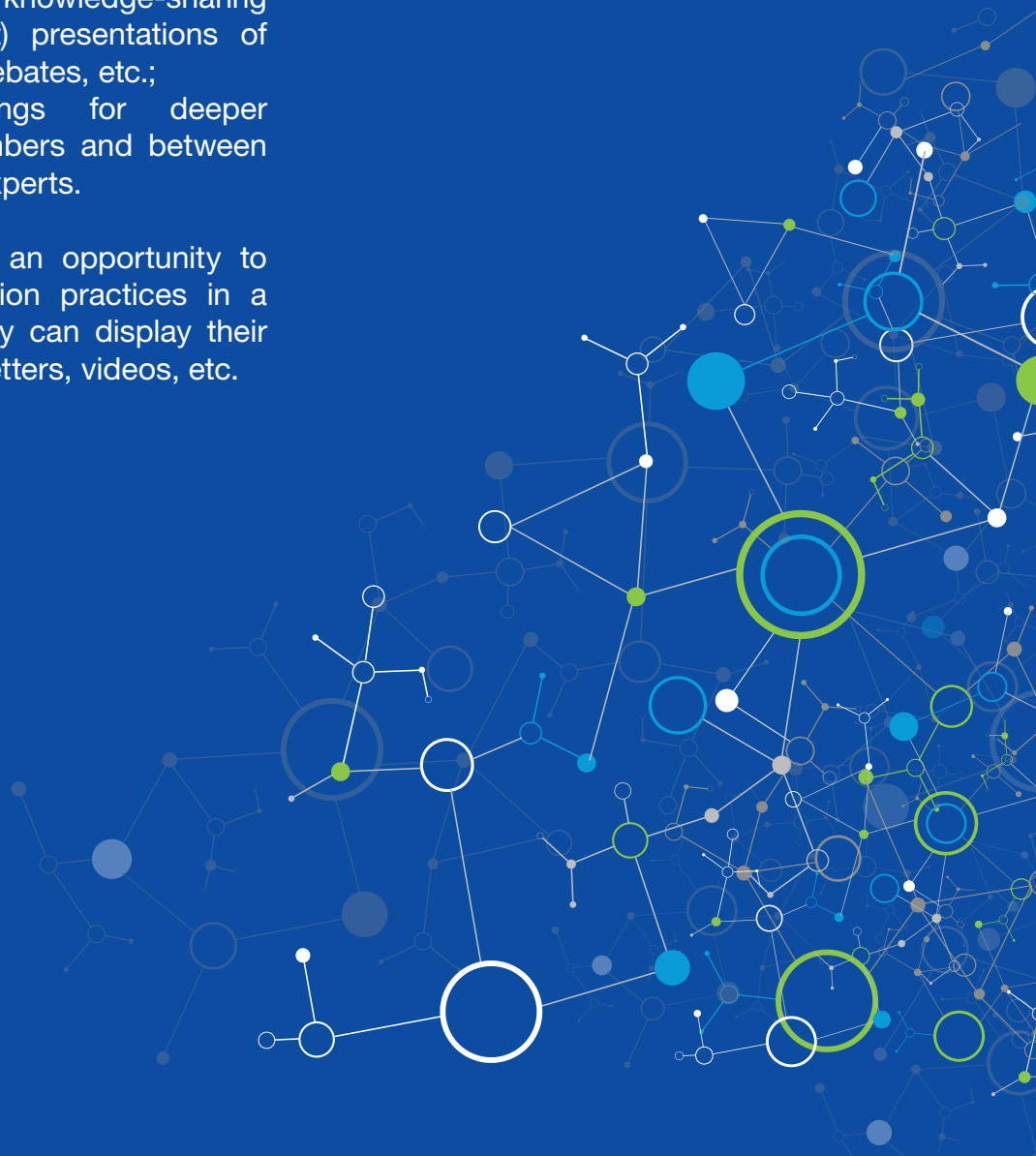
# MEETING OBJECTIVES
